It is a pleasure to report that RB 129, the proposal that would have moved residential fire sprinkler requirements in one and two family dwellings to the appendix of the International Residential Code (IRC), has been defeated. The fire service and our allies were present to ensure the vote was as positive as Baltimore, just with a lot less people. Our IRC Project team and Residential Committee is to be commended for their diligent efforts in making sure the information was distributed to the right people who would ensure their voices were heard. We cannot thank all our dedicated fire service friends who traveled locally and nationally to ensure they were present for another challenge to all our efforts in the past. We will now prepare for the online vote, which will start in a couple of weeks. The positive to this outcome is that our opponents will have to have a 2/3rds majority to overcome what we just ensured in Kansas City.

In addition to the IRC, there were many votes throughout the International Fire Code that were critical to fire sprinklers and I am pleased to say that all votes have been positive to the property and life saving benefits of fire sprinklers

For those communities building new fire, police, or educational buildings should be aware of requirements in the 2015 IBC on storm shelters. See the info that follows. **423.3 Critical emergency operations.** In areas where the shelter design wind speed for tornados in accordance with Figure 304.2(1) of ICC 500 is 250 MPH, 911 call stations, emergency operation centers and fire, rescue, ambulance and police stations shall have a storm shelter constructed in accordance with ICC 500.

**423.4 Group E occupancies.** In areas where the shelter design wind speed for tornados is 250 MPH in accordance with Figure 304.2(1) of ICC 500, all Group E occupancies with an aggregate occupant load of 50 or more shall have a storm shelter constructed in accordance with ICC 500. The shelter shall be capable of housing the total occupant load of the Group E occupancy.

For many communities, your fire alarms are being monitored by central stations. In the event some of you did not know, ADS had a service disruption issue that might be affecting some of your accounts. You may want to check with your businesses and make sure they are aware of the potential issue, and if it affects them that they take any needed action.

Excerpts from their email that discuss the problem and the anticipated correction time follows:

"As you likely know, we've been working to correct a service disruption that could be affecting the transmission of alarm signals in your community. The issue is the failure of two AES radio communication networks that allow our company to monitor alarm signals. AES is the manufacturer of the mesh radio technology utilized by many private alarm companies in our area, including units deployed under the Keltron brand name.

The total number of affected radios is approximately 10,500. The alarm systems will still operate at the protected premises, but may fail to communicate alarm signals to our central station.

To restore service, we must initiate in-person, service visits for every non-functioning radio. Not all affected properties are without monitoring. Many locations have redundant communication paths that allow alarm signals to reach our monitoring station. Our other 20,000 customers remain unaffected by the outage and continue to transmit alarm signals without issue.

We are working with AES (the company that supplies transmitters) and have recruited the help of other alarm companies to accelerate the replacement process. As of October 21, we had completed approximately 3,800 service visits to repair affected radio units with an emphasis on high risk facilities (schools, daycares, hospitals, etc.), as well as locations that are important for expediting the restoration of service. We are on track to restore service to an overwhelming majority of our customers by mid-November. However, a setback due to product shortages, technical issues, weather events or other circumstances would affect our timeline.

We understand that this service disruption has added strain to your efforts in protecting your communities, and we apologize for the inconvenience we've caused. We also thank you for your support, and for your vigilance in ensuring the safety of your residents and businesses.

If you have questions, you can contact our company, and we will try to respond as quickly as possible. But, as you can understand, our entire focus is on resolving this problem and so we might not be immediately available to respond."

It has come to our attention that there is a company in the west suburbs that is selling a faux sprinkler head - preliminary patent pending. Its purpose is to serve as a dual band antenna. It is white and made of plastic. To help locate it, the fusible element is not a glass bulb. Rather it appears to give the appearance to two small arched bars attached to a larger straight one that goes down to the "deflector". We have not seen an actual product, only a diagram. You should be aware that this product could be in your buildings. Common thinking is that this is not allowed, as the codes do not allow anything that gives the appearance of fire protection equipment, but actually is not.
