## A Message from the Board of Directors

For those who receive a certificate following a class from the IFIA, a reminder on the CEUs. Our approval for the Preferred Provider CEU comes from the International Code Council. Their procedure is to give .1 hour per contact hour. So 0.1 CEU is equal to 1 contact hour of class.

On May 19, 2023, the OSFM will be putting on Pyrotechnic-Fireworks Training for Code Officials class at the Aurora Fire Department, Station 8, 3770 McCoy Drive, Aurora. The class will cover Consumer (1.4G) Fireworks Retail Sales, Professional Display (1.3G) Fireworks, and Proximate Pyrotechnics and Flame Effects (Outdoor & Indoor). This class is FREE. Plan now for a two-day fire sprinkler plan review class on June 13 and 14. It will be taught by Ron Ritchey, *Great Lakes Field Services Coordinator*, *National Fire Sprinkler Association*, and will be held in Elk Grove Village.

This <u>in-person</u> program will consist of the requirements of NFPA 13, where you will be guided through an actual review of sprinkler system plans and calculations. It will discuss the importance of employing a systematic review process and identify the documents required for a complete plan review. Participants will review and discuss a submittal of the hydraulic calculations presented with the plans.

It should be noted that the ground breaking report America Burning is 50 years old this year. It is an interesting read, especially the minority report, where it is mentioned that more emphasis should be put on prevention and education efforts.
