We wrapped up another excellent Fire and Life Safety Conference last week, thanks to all those who attended or sponsored the event. We will begin working on the 2024 Conference in June, following the NFPA conference. The first in-person mini-seminar of the year will be on April 28th in Elk Grove Village. The topic will be Mass Timber Construction. The 2021 International Building Code allows for mass timber construction. These buildings are in neighboring states and it will only be a matter of time before they come to your jurisdiction. The IFIA day at the State Fair is Sunday, August 20th. We need volunteers to assist with the event. Please reach out to one of the Board members, or contact the office, for further details if you are interested in participation. We are able to provide parking and gate passes for those attending. While the tent hours are from 10 - 4, if you are able to provide just a couple of hours, that would be greatly appreciated. If your department has an Explorer post, this might be a great opportunity to expose them to some public education activities.

The office has approximately 200 smoke alarms. We have decided to give small amounts to fire departments to carry on their vehicles. Then, should you go to a home that does not have any smoke alarms, you will be able to install one of the ones caried on your vehicle, and immediately reduce a risk. This is not meant to be a smoke alarm campaign, but rather a method to handle an immediate need you come across. We do not have a good way to ship this, so you will need to pick these up, or make arrangements to acquire them. If you are interested in this, contact our office with your department and contact information.
