Close Before You Doze, and New Smoke Alarm Requirements (FLSE)

Sean DeCrane and Jennifer Williams

With only three minutes or less to escape a home fire, educating your community about the importance of working smoke alarms, closed doors, and fire escape plans is more important than ever. UL's Fire Safety Research Institute understands the early warning that smoke alarms can provide and the vital role that they play in addition to closed doors in saving lives from fire. This session will help enhance your knowledge of what the new UL 217 standard means for smoke alarms, fire safety messaging and will provide you with new and creative, research-based resources around the importance of closed doors and fire escape plans.

Protection of Expanded, Exposed Foam Plastic in Racks (CODES)

As recently as the 2013 edition of NFPA 13, there were no requirements for the protection of expanded, exposed, Group A plastic in racks. With the introduction of the 2016 edition of the standard, the first series of design considerations was introduced to the standard. In 2019, additional protection was introduced so that now this commodity can be properly protected. This presentation will discuss what was done prior to 2016, what happened in 2016 showing a video of an actual fire test run by UL, and highlight the requirements as they appear in the 2019 edition.

Discussion will be held on what can be done with those systems that were installed prior to the first series of requirements and the class will be asked if this is a retroactive requirement that should be enforced.

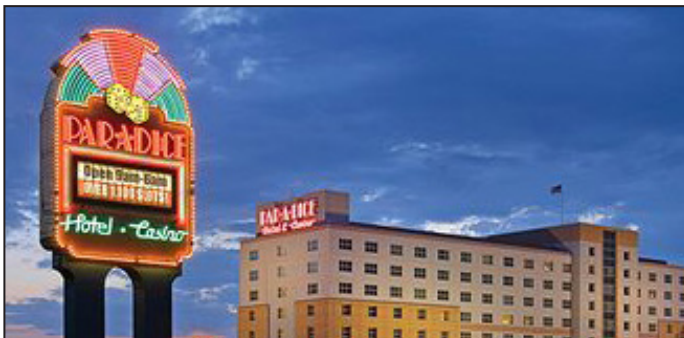

SPEAKER BIOS

KAMAL M. ALJAZIREH

Kamal M. Aljazireh, PE, is an industrial fire protection consultant based in Chicago with experience in hazard analysis and evaluation, hazard mitigation techniques and requirements, code compliance studies, and specification of fire protection features for various industrial applications. His experience focuses on developing fire and explosion risk reduction solutions for industrial processes handling hazardous materials such as flammable/combustible liquids and combustible dusts. He completed a B.S. in Chemical Engineering at Rose-Hulman Institute of Technology, and a M.S. in Fire Protection Engineering at Worcester Polytechnic Institute. Mr. Aljazireh is a chair member of the Chicago Chapter of the Society of Fire Protection Engineers, and an active member of the American Institute of Chemical Engineers.

JEFFREY P. BAKKEN

Jeffrey P. Bakken, Ph.D., is Professor of Special Education at Bradley University where he has taught since June of 2012. He has a Bachelor's Degree in Elementary Education from the University of Wisconsin-LaCrosse, and graduate degrees in the area of Special Education-Learning Disabilities from Purdue University. JOSH FULBRIGHT

Josh Fulbright, the Community Risk Reduction (CRR) Section Chief with SC State Fire, leads a team of seven tasked with fire and life safety data analysis, curriculum coordination, and outreach. Chief Fulbright coordinates statewide CRR through the Fire Safe South Carolina program. He manages fire fatality research of the Community Loss Education and Response Team. Annually, his team hosts quarterly Fire and Life Safety Educator Trainings, a Fire and CRR Summit, and supports local CRR practitioners. As Situation Unit Leader for the Palmetto Incident Support Team and as a State Duty Chief, he manages routine and emergency response coordination of personnel. For nationwide relationship-building, he serves as Team Lead for Vision 20/20 Technical Advisors and South Carolina Representative to the NFPA. He also serves as a Board Director to the NFPA Education Section and as a National Fire Academy Contract Instructor. A native of NC, he served with the Cary Police Department, earning the rank of Corporal and gaining valuable community-building experience. He has a B.A. in Criminology from NC State University and a M.J.A. from Methodist University.
