

Fire Prevention Inspector I - Adams or Morgan County

Description: Under direct supervision of the Regional Manager in the Northern Region, performs beginning level professional fire inspection duties. Utilizes a state vehicle to conduct on-site inspections or assists in more complex inspections. Serves as a contact person in the field of fire prevention inspections with local fire departments. Receives training.

Minimum Requirements: Requires knowledge, skill and mental development equivalent to the completion of two years of college. Requires at least 6 months experience as a Fire Prevention Inspector Trainee and successful completion of training with certification as a Fire Prevention Inspector I by the national fire safety standards organization that has been adopted by the State as the State's fire safety standard; or, requires three years professional work experience performing building inspections, plan reviews or enforcement activities for a public or private entity whose primary function is the administration of fire, building or life safety codes, and with either

certification as a Fire Prevention Inspector I or II by the appropriate national fire safety standards organization or with Office of the State Fire Marshal certification as a Fire Inspector I of a Fire Prevention Officer 1; or 6 years professional work experience performing building inspections, plan reviews or enforcement activities for a public or private entity whose primary function is the administration of fire, building or life safety codes. Requires possession of a valid driver's license, and the ability to travel.

THE SELECTED CANDIDATE WILL BE REQUIRED TO LIVE IN ADAMS OR MORGAN COUNTY WITHIN SIX MONTHS OF HIRE, NO EXCEPTIONS

Public Service Administrator Opt 1-Springfield, Illinois

Description: Under administrative direction of the Division Manager for the Division of Personnel Standards and Education, serves as assistant division manager. Plans, develops, organizes, directs, evaluates, and coordinates the daily operation of the Division. Supervises the Fire Certification Specialist Supervisor and aspects of technical training, test banks and field operations; supervisory authority and responsibility; in the absence of the Division Manager, assumes managerial responsibility.

Minimum Requirements: Requires knowledge, skill, and mental development equivalent to completion of four years of college, preferably with courses in business or public administration. Requires five years of progressively responsible administrative experience in a fire service environment. Requires State of Illinois certification as a Fire Officer II or Advanced Fire Officer. Requires State of Illinois certification as a Fire Service Instructor III. Requires State of Illinois certification as a Fire State of Illinois certificati
